Hereby covenants not to sue and voluntarily releases, waivers, discharges and relinquishes any action or causes of action, aforesaid, which may hereafter arise for himself/herself and for his/her heirs, executors, administrators and assigns prosecute or present any claim for personal injury, property damage or wrongful death against the High Power Rifle and Pistol Club, of Yuma, Inc. of said causes of action, whether the same shall arise by negligence of any of said persons or otherwise. IT IS THE INTENTION OF THE UNDERSIGNED BY THIS INSTRUMENT, TO EXEMPT AND RELIEVE THE HIGH POWER RIFLE AND PISTOL CLUB OF YUMA, INC. OR ANY OF ITS OFFICERS, MEMBERS, AGENTS, SERVANTS OR EMPLOYEES; INCLUDING VOLUNTEERS, FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE. *Initial box when read*

2. Agrees that the foregoing release is intended to be a broad and inclusive as permitted by the laws applicable and that of any portion thereof is held invalid, is in that the balance shall, notwithstanding, continue in full legal force and effect.

Acknowledges that the undersigned has been fully and completely advised of the potential for serious accident incidental to engaging in firearms activities, including the potential for death, personal injury and property damage, and expressly agrees to assume all risks of loss, damage or injury that may be sustained by the undersigned.

4. This agreement shall remain in effect until December 31, 2023 and cancels all previous agreements.
